- Modifier Usage: Properly utilize modifiers to indicate specific circumstances, such as multiple procedures or services performed during a single session.
- Medical Necessity: Learn to link procedures performed to the medical necessity of the patient's condition and the provided treatment.
- Compliance Audits: How to Conduct periodic compliance audits to identify any potential discrepancies and rectify them promptly.
